# Your Tactical Toolkit

Use this guide to help you identify when a situation needs our immediate attention. We've got the professional weight and the strategy ready to go, we just need you to provide the heads-up so we can take the lead and lift the burden off your shoulders.

## THE FDCPA "SMELL TEST" (Collection Abuse)

If a collector does any of the following, they are likely breaking the law. Be sure to document and report it:

**Illegal Hours:** Calls before 8:00 AM or after 9:00 PM.

**Workplace Calls:** Contacting you at work after you told them to stop.

**Abuse:** Profanity, threats of arrest, or constant "robocalls."

**The Gut Check:** If it feels "off" or makes you uneasy, tell us. We trust your instincts.

## THE IRS "RED FLAGS" (IRS Notices)

**Tax Notices & Government Mail:** Tax-related notices can move quickly, and waiting too long may limit your options.

**Review:** Open and review any mail from the IRS, state tax agency, or local tax authority as soon as it arrives.

**Red Flags:** Notices about unpaid taxes, audits, levies, wage garnishment, or liens.

**The Gut Check:** If it looks official, has a deadline, or makes you uneasy, send it to us.

## THE 24-HOUR RULE (Legal & Government Mail)

Time is our only enemy. You must upload these to your portal within 24 hours of receipt:

**Lawsuit/Complaint:** Any document listing a Plaintiff, Defendant, and a Case Number.

**IRS Notices:** Any letter regarding a Notice of Intent to Levy.

**Garnishments:** Any threat to your wages or bank accounts.

**Certified Mail:** Anything that requires a signature is high-priority.
